*Repeated tardiness may result in termination of lessons.

*Attendance is important. Students missing more than 3 classes from February forward will not be allowed to participate in the end of the year recital.

*MISSED CLASSES WILL NOT BE PRORATED. MAKE-UP CLASSES ARE ENCOURAGED.

*Classes with 3 or less students registered will be subject to a 30 minute class session and closure if more students do no register within a 1 month period.

*Credit and/or refunds for missed class(es) due to holiday, vacation, business trips, illness, weather, etc. will not be provided.

*Required dance attire and hair must be worn to all classes. Failure to wear required dance attire and hair will result with student being asked to sit out.

*7 days written notice prior to the 1st of the month is required to withdrawl from any classes. Withdrawls will not be accepted via phone.

*Partial months will not be credited.

*Cell phones should only be used for emergency purposes and are not permitted to be used while in attendance at the studio.

*Parents, legal guardians and adult students, waive the right to any legal action for any injuries sustained on the school premises.
